

## Golden Hammer Evaluation Rubric

The rubric is meant to evaluate the completeness of the application, the quality of the project as described, the challenges faced and overcome, the quality of workmanship, and the recognition of stakeholders involved. It also places a heavy emphasis on safety, which is important in the roofing industry. This rubric gives the judges a systematic way to evaluate each application and ensures that each project is evaluated based on the same criteria.
